Re: Research Attorney Classifications

(1) The Supreme Court hereby creates the classifications of Supreme Court Research Attorneys I, II and III and Court of Appeals Research Attorneys I, II and III as described in the attached documents. The classifications are assigned to the pay grades as follows:

Supreme Court Research Attorney III	Grade 32
Supreme Court Research Attorney II	Grade 31
Supreme Court Research Attorney I	Grade 29
Court of Appeals Research Attorney III	Grade 31
Court of Appeals Research Attorney II	Grade 30
Court of Appeals Research Attorney I	Grade 28

The existing classifications of Research Attorneys I and II, Central Research Attorneys II, and Supreme Court Central Staff Attorneys II are eliminated.

(2) Existing Research Attorneys I and II, Central Research Attorneys II, and Supreme Court Central Staff Attorneys II will be assigned to these classifications as specified below:



(3) Following the implementation of the reclassification, the appointing authority of a Supreme Court Research Attorney I may request the reclassification of the position to a Supreme Court Research Attorney II if the person filling the position has two years experience as a licensed attorney. The appointing authority of a Court of Appeals Research Attorney I may request the reclassification of the position to a Court of Appeals Research Attorney II if the person filling the position has two years experience as a licensed attorney. When a position reclassified in this matter becomes vacant, it will revert to the original classification.
